## 4. Criteria

### Criterion 1: Relevance (40 marks)

This criterion considers the concept, plan and intention of the applicant. This criterion also considers the impact of the proposed programme to the formation of the creatives, collaborators and participants when relevant. Specifically the applicant should answer the questions below in not more than 500 words:

- a. How relevant is this programme or outgoing mobility project to you at this stage of your creative and/or artistic development? (15 marks)
- b. What are the merits and value of the selected platform? (10 marks)
- c. How will this platform impact your development at this stage of your formation? (Applicants should also consider how the proposal aligns with the principles within the Right to Culture – Resource Kit and the Charter for the Status of the Artist as in Section 1) (10 marks)
- d. What are the plans beyond the implementation of the proposal? (5 marks)

#### Mandatory Documentation:

### Criterion 2: Management (20 marks)

This criterion considers the level of commitment and preparation prior to the proposal as well as the proposed plan to deliver and achieve the objectives of the application. The following questions are to be addressed in not more than 300 words

- a. Define the expected benefits of this opportunity? (10 marks)
- b. Is the selected programme in line with your current needs? (10 marks)

Criterion 3: Opportunities (20 marks)

This criterion considers the engagement of the creatives and creation of new national and international networks. Engagement refers to the role, the nature of involvement and the experience of the creatives and collaborators when relevant. The following questions are to be addressed in not more than 300 words:

- a. Will this programme expose you to new networks and platforms? (10 marks)
- b. Will the programme provide you with further opportunities further networking and international collaboration? (10 marks)

Criterion 4: Budget (20 marks)

This criterion considers how well planned and realistic the presented budget plan is. - a. Please provide a clear budget breakdown including expenses directly related to the proposed project. (10 marks)
- b. Kindly explain the rationale for the expenses of the project. (5 marks)
- c. Provide quotations to support your budget. (5 marks)
